The Village of Arcade Board of Trustees is requesting a review and recommendation from the Planning Board regarding the raising of chickens in the Village. This has been proposed and the Board would like to know if this falls within the confines of the Comprehensive Plan for the Village.

The following are the minutes from the VOA Board meeting explaining the situation:

**CHICKENS IN THE VILLAGE**

The Mayor received a letter from VOA resident John Camiolo regarding the keeping of chickens in the VOA. Although this discussion has been had before John wanted the VOA Board to reconsider the idea of allowing residents to keep chickens within the confines of the Village. Zoning Officer, Chris Lexer, suggested the VOA send a request to the Planning Board to review the Comprehensive Plan to see if the ownership of chickens would fit within the confines of the plan. A concern raised by Trustee Rule was the idea that first it is chickens, then will it be other farm animals? How do we protect the Village?

The Mayor and the Board approved the idea of approaching the Planning Board for their opinion. Clerk Treasurer Kraft will send a letter requesting a review of the idea of raising chickens in the Village. Chris Lexer will attend the Planning Board meeting and explain the position of the Village
