PLEDGE OF ALLEGIANCE

Mayor May opened the meeting with the Pledge of Allegiance.

PRESTOLITE

Chuck Bell, Consultant for Prestolite, discussed the possibility of the Village of Arcade applying for a Community Development Block Grant (CDBG) on behalf of Prestolite. The grant proceeds would be used by Prestolite for significant investment in the current facility as well as equipment upgrades that could result in contract opportunities which in turn would create job opportunities. Prestolite contacted the Wyoming County IDA which suggested the CDBG grant. The grant consists of federal monies that are passed through the state. A public hearing must be held and any record of public hearing becomes part of the grant application. The Mayor requested more information be made available to the Board before considering this proposal. Mr. Bell will send the information to the VOA Board.

WWTP EXPANSION UPDATE

Jason Foote updated the Board on the progress with the WWTP expansion. Paving will proceed tomorrow. There are numerous punch list items to be addressed. Jason will email the punch list to the VOA board. The treatment components are working well.

PROJECT UPDATE

Flow study for Phase 1 of the I&I rehab work, is complete; data is being compiled at this time.

The data logs for the Sandusky Springs test wells are in and they are getting baselines for the aquifer levels.

The Village has been awarded a \$100,000 grant through Environmental Facilities Corporation (EFC) for Phase 2 of the I&I rehab work. The duration of the actual work will be about 1.5 months. The tentative dates for the project are submit project plans and proposal for review in March 2018, advertise for bids in June 2018, completion by August 2018.

DEACON DRIVE DRAINAGE ISSUES

Rebecca Hoyt approached the Board to discuss drainage issues on Deacon Drive. The ditch, on the north end of Deacon Drive overflows onto the properties. Some of the backyards have had standing water in the yards for weeks and the road floods during heavy rains. Superintendent of Public Works Kilburn stated there are a few issues, the ditch needs to be dug out again, and also the railroad tracks hold water back because the tube under the tracks cannot handle the water. This area has always been a wet area. Trustee Rule stated the ditch should be maintained each year; perhaps we need to create a maintenance plan for yearly review. Rebecca left photos with Superintendent of Public Works Kilburn. Trustee Rule, Trustee Koerner and Superintendent of Public Works Kilburn will go up and take a look at the ditches and check the flow to see what is going on. Next meeting they will bring an idea to the board.
