

# CHAPTER 1

## CODIFICATION OF ARCADE VILLAGE ORDINANCES

### ***SECTION 1-1. ADOPTION OF CODE.***

This codification, consisting of Chapters 1, 2, 4, 5, 7, 10, 13, 15, 19, 22, 25, 28, 29, 31, 34, 37, 40, 43, 46, 49, 52, 55, 58, 59, 60, 61, 64 and 67, each inclusive, is hereby adopted and enacted as the "CODE OF THE VILLAGE OF ARCADE" and shall be treated and considered as a new and original comprehensive code which shall supersede all other general and permanent laws and ordinances passed by the Village Board prior to the enactment of this Code, except such as by reference thereto are expressly saved from repeal or continued in force and effect for any purpose.

### ***SECTION 1-2. REPEAL OF OTHER ENACTMENTS***

All provisions of such Code shall be in full force and effect from the date this codification becomes effective and all ordinances of a general and permanent nature of the Village of Arcade, and not in such Code or recognized and continued in force by reference therein, are hereby repealed from and after the effective date of this codification. No resolution, rule, regulation or utility rate of the Village, not specifically mentioned, is hereby repealed.

### ***SECTION 1-3. ADDITIONS AND AMENDMENTS TO CODE***

Any and all additions or amendments to such Code, when passed in such form as to indicate the intention of the Village Board to make the same a part thereof, shall be deemed to be incorporated in such Code so that reference to the "CODE OF THE VILLAGE OF ARCADE" shall be understood and intended to include such additions and amendments.

Chapter 46, entitled "Public Hearings on Local Laws and Effective Dates of Publication" heretofore adopted was superseded and became effective on September 26, 1983 is hereby made a part of this Code.

The Zoning ordinance of the Village of Arcade, as heretofore adopted without a chapter number is hereby incorporated herein so that the same shall hereafter be Chapter 64 of the Code of the Village of Arcade.

#### ***SECTION 1-4. VILLAGE CLERK TO MAINTAIN OFFICE COPY***

A certified copy of such Code shall be kept on file with the Village Clerk in such form as the Village Clerk may consider most expedient. It shall be the express duty of the Village Clerk, or someone authorized by him or her, to insert in their designated places all amendments or laws which indicate the intention of the Village Board to make the same a part of such Code when the same have been printed or reprinted in page form, and to extract from such Code all provisions which may be from time to time repealed by the Village Board. This copy of such Code shall be available for all persons desiring to examine the same and shall be considered the official "CODE OF THE VILLAGE OF ARCADE".

#### ***SECTION 1-5. REPEAL***

All ordinances or local laws or parts of ordinances or local laws in conflict herewith are, to the extent of such conflict, hereby repealed.

#### ***SECTION 1-6. SEPARABILITY***

If any chapter, paragraph, section, subsection, sentence, clause, phrase, subdivision or provision of this Code shall be held invalid or unconstitutional, such portion shall be deemed a separate, distinct and independent Provision and such holding shall not affect the validity of the remaining portions thereof. The Village Board hereby declares that it would have adopted every section, subsection, paragraph, sentence, clause and phrase of this Code regardless of the fact that any other section, subsection, paragraph, sentence, clause or phrase be declared invalid.

#### ***SECTION 1-7. EFFECTIVE DATE***

This Code shall take effect on March 10<sup>th</sup>, 1969, except as herein otherwise stated or provided.
